Vendor spaces start at 10' x 10'. The fee for each Service-Provider, Arts, Crafts, Clothing, or alike vendor space is \$175 as is for food or drink vendor space. Additional space will be charged \$100 per extra 10' x 10'. All vendors must carry vendor liability insurance. In Ventura, **food vendors CANNOT use Styrofoam** food or beverage containers; please consider using sustainable packaging.

If your company is not selected for any reason, your payment and application will be promptly returned to you by certified mail within 10 business days after receiving your registration packets.
