Please complete this form for registering in the **2026 Ventura Earth Day Festival, organized by the MERITO Foundation** in collaboration with **the City of Ventura Sustainability Division**. Accepted Electric Vehicles (EV) or Hydrogen Cell fuel car vendors will be notified by either phone or email with all final details within five business days of receiving your registration packets. All accepted EV or Hydrogen Cell fuel car vendors must display proper licenses at the festival site and comply with all the city, state, and local regulations. Vendors are responsible for providing their own tents, tables, and chairs.

EV or Hydrogen Cell Fuel car dealers can utilize no more than 20' x 20' of physical space in the area designated for the EV show at Park Plaza (the event map will be sent with the confirmation for details of where to park the vehicle and how to drive it into the park). The fee for each vendor space is \$500. Additional space will be charged \$250 per extra 10' x 20'. All car dealers must include a certificate of liability insurance.
